The Organizing Member Federation will apply a fine of CHF 1'200 per missing judge (to be paid to the LOC) should a federation fail to bring the required number of judges. This fine must be paid to the LOC by April 1, 2025. All judges must have a current valid FIG Brevet in Acrobatic Gymnastics.
